Purpose:

Outcomes:

Through the 2017 Climate Summit, CNU seeks to empower and enable its membership to move the needle on knowledge, expertise, and practice around specific climate issues. We plan to identify member-led working groups to develop strategies, tools, and techniques that contribute to the climate change conversation in a meaningful way.

Learning from the Experts:

We are asking representatives from international climate initiatives, local government, leading environmental organizations, and activist groups to share their work and insight:

- How is your organization/initiative contributing to the climate change conversation, specifically as it relates to the built environment?
- How do you think an organization like CNU might be most effective?

Breakout Sessions:

Attendees will have the opportunity to participate in four breakout sessions that will dive deeply into a specific climate issue. During the breakout sessions we ask participants to consider the following:

- Where does CNU have expertise? Where could CNU expand its knowledge-base?
- How does the specific climate issue affect the economy of local communities?
- How can we plan and design equitable solutions and tools to address climate impacts?
