- Developing next steps for our vibrant Urban Villages, as their Development Agreements expire

The Development Services Director manages, directs, plans, and organizes the daily operations of the department.

Specific responsibilities include:

- Analyzing community needs and forecasting for future requirements
- Developing and monitoring standards and service levels.
- Leading and directing the department's staff and budget
- Administering the City's Comprehensive Plan and ensuring actions are consistent with city goals
- Making recommendations to the Mayor's office, as well as providing technical advice and collaborative services to other departments
- Executive representative to the City Council Land and Shore Committee
