## Meet the 9 nominees selected for the 2025 Freeways Without Futures report

Campaigns offer a roadmap to the future of American highway infrastructure.

Washington, DC - The 2025 Freeways Without Futures report is <u>available now!</u> Meet the nine campaigns working to transform the highways in their communities into assets like city streets, housing, green space, and more.

The history of urban freeways in North America has been one of inequity and induced demand. Now, with many of these hulking, burdensome highways reaching the end of their useful lifespans, communities are looking for alternatives to costly highway repair and expansion. The nine campaigns in this report offer a pathway to better health, equity, opportunity, and connectivity in every neighborhood, while reversing decades of decline and disinvestment.

The 9 nominated freeways in the report are:

- I-35 in Austin, Texas
- NY State Routes 33 and 198 in Buffalo, New York
- Interstate I-980 in Oakland, California
- Interstate 45 Expansion in Houston, Texas
- Interstate 175 in Saint Petersburg, Florida
- IL 137/Amstutz Expressway/Bobby Thompson Expressway in Waukegan and North Chicago, Illinois
- DuSable Lake Shore Drive (US 41) in Chicago, Illinois
- US-101 in San Mateo County, California
- US-35 in Dayton, Ohio

The campaigns featured in this report illustrate the evolution of the Highways to Boulevards movement and envision reparative infrastructure that reknits communities, addresses the damage caused by these highways, and centers community priorities.
